 3<sup>RD</sup> DEPOSIT OF \$87,500.00 U.S DOLLARS GUARANTEE SHALL BE PAID, NO LATER THAN MARCH 22<sup>ND</sup>, 2003  
 BALANCE OF \$87,500.00 U.S. DOLLARS GUARANTEE SHALL BE PAID, NO LATER THAN APRIL 19<sup>TH</sup>, 2003,  
**ALL PAYMENTS MUST BE MADE IN THE FORM OF WIRE TRANSFER, CASH, CERTIFIED CHECK OR MONEY ORDER PAYABLE TO MARTINEZ, MORGALO AND ASSOCIATES.

Any musician hired to perform on this agreement is free to cease service hereunder by reason of any strike, ban, and unfair list, order of requirement of Local 802 of the American Federation of Musicians. The agreement of the musicians to perform is further subject to proven inability due to sickness, accidents, or accidents by means of transportation, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond the control of the musicians.

In the event the employer fails, neglects or refuses to pay the wage or other payments agreed upon herein and suit is commenced to recover the aforesaid or any part thereof, the employer shall be responsible for the attorney's fees, court costs and expenses incurred in recovery of the sums due.

**Purchaser shall pay and hold ARTIST harmless of and free of and from any and all taxes, fees, dues and the like to the engagement hereunder and the sums payable to the ARTIST shall be free of such taxes, fees, dues and the like.**
